- Sanctioning (Katie Pond)

There are two potential changes for the AMA rule book, where a rider must be 14 or older to ride a 200cc - 300cc bike and 16 or older to ride a 301cc bike or larger. - Director of Competition (Jeff Irwin)
 - o Jeff Irwin was not present during the meeting this evening.
- LAO (Ted Cabral)
 - o Ted Cabral introduced himself to the District and its members this evening. He has a pretty extensive background in racing and dirt bikes. He is looking forward to making the LAO bigger and better!
- Clubs/Promoters/Members Question/Answer *This is not for club announcements*
 - o Jeff Smith has concerns regarding Wilseyville and how trophies are handled for a dual-sanctioned event. He also has concerns how advancement points are issued at Wilseyville. Jeff pointed out multiple youth classes that District 36 riders did not get trophies because District riders were scored with WHS. Jeff points out the Rule 7.2.1 states that racers get a trophy. Also, his last issue was how at Wilseyville, some youth classes combine A, B and C riders in one race.
 - John Davis states the rule is actually 3.2.8, which applies to youth. Rule
 7.2.1, is essentially the same rule but for adults.
 - Justin Silkwood, from Nor-Cal MC, explains how most classes correspond from WHS to D36. There are a few that do not match up.
 - Brad Rosbach advises this will be moved to the Board of Directors meeting as this is a procedural rule.
 - O Jeremy Carlin of PDMC is interested in the pay structure of LAO. The only two disciplines who pay LAO are CC and Enduro. Brad Rosbach states that Dirt Track uses private venues. Ralph Lee says Dirt Track pays a flat fee. Kolby Butcher of RRMC asks how he can change the fee structure as his club also uses private property. Both Brad Rosbach and John Davis advises submitting these requests to the Board of Directors to review. Brad also suggests waiting to see what plans Ted Cabral have for the 2024 LAO program.

- Adhoc Committee Updates
- Non Agenda Items (There will be 5 minutes TOTAL allowed)
 - o The topic of trophies from Wilseyville will be addressed here. Brad Rosbach gives time for ample discussion.
 - John Davis states past precedence is that clubs would trophy both series (in this case: WHS & D36).
 - Justin Silkwood states that Nor-Cal MC follows D36 rules as in how they distribute trophies; however trophies are only issues for the results posted the day off, not when D36 results are filtered and posted a week later.
 - Jeremy Carlin explains how riders sign up for a dual-sanctioned event to help with the confusion. For a dual-sanctioned event, such as Wilseyville, all riders must enter into a WHS class and their D36 class as well to be scored the day of and their respectful D36 class.
 - Jeff Smith reiterates that there were many youth class where D36 riders did not receive trophies. Jeff states that Wilseyville is running 2 sanctioned events (WHS & D36), then both events should receive trophies.
 - Billy Goodno asks Justin Silkwood if NorCal would be willing to issue trophies to the D36 riders who earned trophies, Nor-Cal MC would be willing to do that. Moving forward, NorCal MC would like to figure

- something out because mailing out trophies weeks after, for years to come does not make sense.
- John Davis makes a motions that NorCal MC pays out trophies to the D36 classes that were scored with multiple classes at Wilseyville. This must be done within 60 days as per the District 36 rulebook or a fine will be assessed.
 - 9 yay; motion passes
 - Cat Swenston will help facilitate getting results to NorCal
 MC. John Davis states that the 60 days starts from today.
- Bruce Hendrickson requested the BOD review some supplemental rules for Enduro. Because they were submitted within a few days of the meeting, Brad suggests tabling this topic to January.
