



## 2026 D-36 CROSS COUNTRY CHAMPIONSHIP SERIES MEET HOSTING AGREEMENT – page 1 of 2

This Document when signed by the hosting Club/Promoter is an agreement that the Club/ Promoter hosting a District 36 Cross Country Championship Series meet will abide by the following:

### The Club/Promoter agrees:

- That the meet is the Club/Promoter's responsibility to run and properly staff with District 36 having an advisory roll only. District 36 officials, if asked by the club / Promoter to help, will make every attempt to assist as needed.
- To supply a copy of the AMA sanction and Insurance Binder for the meet to the District 36 discipline Steward & Director of Competition at least one week before the meet.
- To abide by the AMA rulebook, District 36 Operations Manual and any supplemental rules and polices.
  - As a reminder, per D36 rule 5.8.1, an emergency plan for the CC Steward, and an **ALS Paramedic** is required to be on site at all times. A BLS Staffed Ambulance is not sufficient without an attending ALS Paramedic.
  - Additionally, trophies per D36 rules of 1 for 1<sup>st</sup> place, and 1 for every 5 riders (or the greater portion thereof) are required for all classes, and a participation trophy is required for all other riders in all 50cc classes.
- To submit an informational flyer based on D36 Flyer requirements at least 45 days prior to the date of the meet for review and approval by the Discipline Steward.
- To submit meet specific promotional video clips, pictures and content at least 30 days prior to the date of the meet so D36 may market your meet.
- To use a District 36 approved Scoring Team and System.
- Promoter is responsible for setting up home check and scoring shoot.
- D36 will require two (2) members/ volunteers from each club/promoter to assist with home check for the ENTIRE duration of each day's races. One (1) individual will be required to work with scoring by hand scoring alongside the D36 representative also performing handbook scoring. The other one (1) individual will be responsible for assisting home check in whatever is deemed necessary to best facilitate a fluent scoring program ie: flagging, wiping number plates, guiding riders etc.
  - Penalty: If a club or promoter cannot or chooses to forgo proving these individuals, the club or promotor will be charged a \$100 per person per day fee.
  - Note: The two (2) individuals can be interchanged or swapped out, however lapse in coverage on these positions is unacceptable.
- D36 will require one (1) volunteer from each club/ promoter to assist D36 officials with Tech inspection both days of the event.
- D36 now requires clubs and promoters to enforce their own venue rules ie: spark arrestors, disposable tear offs etc.
- That bike inspection for equipment compliance is required and to use the District 36 Tech Crew for transponder inspections at all Cross-Country Races. An Exception is if the club has the equipment to check scoring transponders and knowledge of requirements, they may opt to have their own personnel perform tech inspection.
- Clubs and promoters shall pay District 36 via check for District 36 cross country scoring crew. This can be added to the fees under the District 36 Schedule of Event Fees form.
  - Payment shall be calculated as (number of racers x (multiplied) by \$4.00) = total amount due.
- District 36 cards required of all entrants ***participating in and receiving Championship and/or advancement points for District 36 Meets.***



## MEET HOSTING AGREEMENT –page 2 of 2

- LAO fee required of all entrants *in District 36 Meets. Exception: this fee is not due for any District 36 Officials competing in any event(s)*
- In combined meets (ie: AMA WHS and D36, or D36 and MRANN) all applicable D36 rules must be followed in order for the meet to be part of the **District 36 Championship Series.**
- AA/Pro Payback/Purse minimum amounts of 75% of AA/Pro entry payback or \$1500 minimum purse.
- Provide an announcer during the meet.
- To provide a designated and clearly marked pit area for the purpose of maintaining access
- To identify the following personnel to the District 36 Stewards for the duration of the event:
  - o Event Chairman/Primary point of contact
  - o AMA Qualified Event Referee
  - o Sign-ups/Race Registration Coordinator
  - o Medical and Safety Coordinator
  - o Final Sweep to clear course after each race
- Will utilize a sound system, to be provided by D36 or the host, good enough for all rows to hear the riders meetings.
  - o If the D36 system is required, a \$100 deposit is required, and will be refunded upon verification that no parts are missing or broken, that the generator utilized has been topped with fuel, and the system has been properly packed and stowed in the D36 trailer.
- Agree to abide by all rules pertaining to D36 Committeemen for free camping, free entry, and half off race entry for Committeemen or approved family member for the discipline that they are a Committeemen for.
- To submit in a timely manner, all required post-meet paperwork including D36 Referee Report, Membership applications and Schedule of Event Fees, AMA injury, and membership reports.
