  - o Dirt Track transponders (Jeff Katarzy)

- Revisiting the discussion for transponders for the Dirt Track series. Lodi MC is willing to give their old system to the District 36 GP series. - Stipend/Mileage for Media Manager (Amanda Carlin)
  - A proposal was sent to the Board of Directors presenting a couple different options regarding reimbursement for the Media Manager.
  - It was asked if there was mileage already approved, per the minutes, mileage reimbursement was approved for a month until the March (current) meeting.
  - Amanda Carlin stated her goal was to attend 75% of all races of each discipline.
  - Billy Goodno has concerns that if we start paying mileage for the Media Manager then where does it end? There are sweepers who put in hundreds of dollars to their bikes to provide a great deal of service to our riders on course as sweepers. D36 LAO and Other D36 Clubs/Representatives Attend Park Access Mtg

**SVRA PARK SEARCH** – On Feb. 16, the LAO, Jerry Fouts, and several D36 Clubs attended the State Park Public Meeting in Pleasanton for the Off-Highway Vehicle Access Project. D36 members showed support for our OHV Program and offered input into new efforts such as the CA OHV Access Project to find a new SVRA.

**POST STORM REPAIRS AT SVRAS** - Besides giving input into the search process for a new SVRA, the LAO was able to talk with Parks leads about the import of reopening SVRAs as soon as possible once repairs are completed. On the day after the Pleasanton meeting, the LAO stopped by Carnegie to meet with the Chief Ranger about the status of post storm repairs. Good news is they had brought on several additional heavy equipment crews to help with repairs. Reopening the park is also depends on when the heavy rains abate but they said they are committed to reopen as soon as possible.




**COMPETITION PERMIT BILL INTRODUCED** - **SB 708 was introduced** with language that would authorize State Parks to add a new in-house online permit program. It would allow the owners of competition motorcycles model year 2022 and newer to obtain an ID decal.

The LAO continues to work with Senator Jones on SB 708 to prep for first hearing that will be at the end of March before the Senate Natural Resources Committee.

#### Background:

Beginning in 1972 and until 2003, the CA DMV issued GREEN Sticker identification to any off-highway motor vehicle (OHV) that applied. The CA ARB passed a regulation in the late 1990's requiring all OHVs to be certified to an air emissions standard. Because some OHV manufacturers either could not or would not certify some of their OHVs to the new CA ARB standard, a second RED Sticker identification was issued beginning with 2003 model year OHVs, specifically for motorcycles and all-terrain vehicles that did not meet the CA ARB GREEN Sticker identification air emissions standard. Those two means of

identifying all OHVs operated on public lands in CA remained until 2019 when the CA ARB eliminated RED Sticker identification for all 2022 and newer OHVs that could not meet their air emissions standard. This new regulation has caused conflicts with state and federal agencies that historically have required some type of OHV identification sticker at sanctioned events on public lands.

**POST STORM REOPENING ON MENDOCINO** - After concerns raised by a member at the Feb. BOD meeting about the Mendocino's storm related closure orders, the LAO met with Brad Rosbach and Matt Finnigan/NBMC and discussed issues and subsequently sent formal communications to the Mendo Forest Supervisor requesting a written response and update on the post storm mitigation and reopening strategy. The Forest said they are working on a written response.

Also, the LAO discussed that same issue with the Upper Lake and Grindstone District Rangers on the March 14 FireScape Mendocino Core-Team Call (the LAO is a core-member representing OHV) and both District Rangers stated their commitment to completing storm mitigation and reopening both units as soon as possible. The recent storm resulted in a large slide on the Elk Mountain Road/M! several days ago which certainly complicates ongoing repair efforts on that side of the Forest. D36 has reached out to Lake County Public Works regarding their plans on repairing the Elk Mountain Road.

**PARTNERSHIP WITH PWORA FOR REOPENING CLOSED ROUTES** - The LAO met with the PWORA board on March 14 to review their efforts to reopen OHV routes on the Upper Lake Ranger District that were closed due to heavy winter storms that downed hundreds of trees. They will restart work parties once the snow melts and continue to work with the Forest to hold some chainsaw certification classes on both side of the Mendo. The LAO is also working with them on getting classes going.



**ANNUAL D36 CLUB MEETING WITH MENDOCINO NF** – The LAO has worked with the Mendocino NF leadership team and has found a time where they can meet via zoom with our D36 clubs that use the Forest. Our annual meeting is slated for March 29 at 1:30pm. This is a great opportunity for D36 club leads to discuss permits and other issues and to meet with FS staff and line-officers to get updates on OHV recreation including post storm closures and reopening.

**AUDIT OF OHV TRUST FUND** - Due to the LAO Program's concerns about the long term fiscal viability of the OHV Trust Fund due to the ongoing deficit spending by the OHV Division and Parks - to subsidize activities that DO NOT benefit OHV recreation — it continues to work with Legislators on submission of a REQUEST FOR AN AUDIT that will be submitted this winter. The audit is expected to highlight deficit spending on unwarranted projects and funding shortfalls that could impact the operation of SVRAs and grants to federal and county agencies. The audit is also expected to find possible solutions to fiscal shortfalls.

**SxS SAFETY** — The LAO continues to work with State Parks interagency SxS safety team on solutions to address illegal and rogue activity by certain SxS groups and the growing number of accidents between dirt bikes and SxSs. As part of our joint effort with Parks, the LAO is doing research on existing online OHV safety courses, the LAO took the online OHV safety courses offered by OR State Parks and UT Parks and Recreation.

The LAO expects that Parks will require some form of REQUIRED education certificate similar to other states such as OR and UT before riding a SxS on public lands. It would most likely start off with a required online cert. but if that is not effective than an in-person field training would also be required.

PROTECTING WALKER RIDGE RIDING AREA FROM WIND PROJECT - The D36 LAO continues to work with our conservation and tribal partners to put an end to the 20+ years effort by both Dem and GOP administrations to site a 4K acre wind energy project over the existing road and trail network along Walker Ridge near Indian Valley Reservoir. The strategy is to have that 4K acre plot added into the Berryessa Snow Mountain National Monument. It is important to note that the Knoxville OHV Area and portions of the Upper Lake and Stonyford Ranger Districts are in the Monument and contain many OHV routes used for competition and casual use and those uses are protected in the Monument designation.

Thanks to the hard work of the LAO and other OHV leaders working with conservation groups about 10 years ago, the Monument was designated in 2015 with strong protections for existing and new OHV recreation including competition events and casual use.

Those OHV protections will be extended to the Walker Ridge area when it is added to the existing Monument. Having the additional land protected from energy development will also help the LAO and others finish the Monument OHV Travel Plan that has been put on hold until the energy issue is settled.

**EDUCATION OF NEW LEGISLATORS in 2023** – Again, there will be an historic number of new legislators coming to Sacramento after the fall election. This massive sea change is due to a large number of current legislators being termed out. The LAO Program has asked the OHV Division to partner with us in a joint effort to educate (both in-person and in the field) new legislators and their staff about the OHV program and its many positive and pro-active tenets including conservation, restoration, LE, and safety. Field trips for legislators/staff to local SVRAs such as Prairie City SVRA have proven highly effective in helping them understand and appreciate the value of our program.
